

## Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA-HEERF II) American Rescue Plan Reporting (ARP-HEERF III) Reporting Requirements for Funding for Students

The following information must appear in a format and location that is easily accessible to the public. This information must also be updated no later than 10 days after the end of each calendar quarter (September 30, December 31, March 31, June 30) thereafter, unless the Secretary specifies an alternative method of reporting:

### 1.

**Dragon Rises College received \$29,390 from the CRRSAA and ARP (a)(1) and (a)(4) programs for the purposes of Emergency Financial Aid Grants for students.**

The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of the date of submission (i.e., as of the initial Report and every calendar quarter thereafter).

**Dragon Rises College has distributed \$29,390 of Federal funds in Emergency Financial Aid Grants to students as of December 31, 2021. All funds received have been disbursed as of 03/31/2022.**

**Graduate students exhibiting financial need were awarded block emergency grants. Dragon Rises College has disbursed all CRRSAA and ARP money as of the end of the Fall 2021 semester.**
